**Notice Regarding the Status and Completion of Share Buyback,

Dexerials Corporation (the “Company”) announces that the Company has acquired its own shares as follows with respect to matters concerning the share buyback pursuant to Article 459, paragraph 1 of the Companies Act of Japan and Article 35 of Dexerials’ Articles of Incorporation. The acquisition of treasury shares pursuant to the resolution at the meeting of the Board of Directors held on November 13, 2024 has been thereby completed.
